

MEMORANDUM OF UNDERSTANDING (MoU)

Preamble

This Memorandum of Understanding (MOU) is entered into by and between the Unique Pub International, hereafter referred as UPI (Unit of KVR Scientific Services), registered under MSME with UAN of AP08D0045680, GSTIN of 37BALPV2944Q1ZN, IEC (Importer & Exporter Code) of BALPV2944Q and the..... **Unique Pub International (UPI)**
(Name of College / Institute / University) hereafter referred as INSTITUTION with a registered address at**2-21A, Scientist's Home, Kambham Vari Street, Duttalur, Nellore-524222, Andhra Pradesh, India**.....
(Address of College / Institute / University) on **01/06/2018**. Hereby, both UPI and INSTITUTION both collectively called as PARTIES.

Objective

The PARTIES recognize the benefits to be derived from increased collaboration, cooperation and interaction for the further promotion and understanding of research activities, publishing of scientific papers and assistance in support of other academic activities such as scientific conferences, UPI Question Paper Bank, Online Certification Courses etc.

Purpose

The purpose of this MOU is to define the areas for fundamental and academic research in which the PARTIES desire to work together in the future for their mutual benefit to foster a collaborative framework between UPI and INSTITUTION with a view of benefiting from each other's initiatives, working procedures and to support collaboration among the researchers associated with both PARTIES.

Scope

This MOU sets forth the intentions of both PARTIES for increased collaboration, cooperation and interaction and does not create any legally binding commitments. If the PARTIES later agree to undertake specific joint projects with legally binding obligations, they will develop separate written agreements for such projects, setting out each Party's contributions, deliverables and budgets.

Role of UPI

- UPI shall provide all scientific services to students / faculty / researchers of INSTITUTION with waiver.
- UPI shall support the INSTITUTION for scientific symposiums / conferences / seminars / workshops which may be national or international and it may be chargeable for service with mutual understanding.
- UPI shall take or organize training classes for students / faculty of INSTITUTION, if INSTITUTION requests experts in that particular area.
- UPI shall take up the academic projects offered by INSTITUTION upon agreement.
- UPI shall offer the services to INSTITUTION such as Journal Publishing, Proof Reading for Dissertation or Thesis / Manuscripts of Students / Faculty, Events Organization, Book Publishing, Plagiarism Check Service, Resume/CV Making Service and other upcoming services.
- In case of any new service being introduced by UPI in future that will also come under this MoU upon mutual understating.
- UPI shall offer technical support to INSTITUTION for Massive Open Online Courses (MOOCs) / Any Plagiarism Software(s) needed etc upon request.
- UPI shall follow the strict criteria for review process of manuscripts and same will be followed for INSTITUTION.

Role of INSTITUTION

- Head of the Institution / Principal / Head of the Department shall provide necessary information during setup of necessary login credentials for INSTITUTION (or) for confirmation of Faculty, Students / any other.
- Head of the Institution / Principal / Head of the Department of INSTITUTION shall allocate time and schedule for training sessions on the usage of the services offered by UPI.
- INSTITUTION shall provide facilities for implementation without charging anything from the UPI when organizing seminars / conferences / workshops etc in INSTITUTION. However, normal functioning of the INSTITUTION shall not be disturbed and if any purchases needed for that, it's the responsibility of UPI when conference / seminar / workshop or any other activities organizing by UPI.
- INSTITUTION shall appoint a person for discussion of any service needed with UPI as College / Institution / University Representative.

INSTITUTION Benefits

- No need to take institution membership and working professionals / students of MoU College / Institution / University can take a membership according to their qualification, if they interested.
- INSTITUTION has reserved 15% waiver on all types of services offered by UPI.
- INSTITUTION has also reserved 15% waiver on all types of membership fee.

- Support to their scientific events / any other scientific programs and academic activities.
- Single scheme (Scheme I only applicable) for book publishing (irrespective of number of authors).

General Clauses

- If the circumstances warrant discontinuance of the usage of services by INSTITUTION (or) UPI decides to discontinue its services to INSTITUTION, such discontinuance will be considered after mutual discussion of both PARTIES. The decision to discontinue from this MoU will be implemented with giving three months prior notice by either side and upon mutual discussion.
- This MOU shall be effective as and when executed by or on behalf of both PARTIES.

General Provisions

- Both the PARTIES have full power and authority to enter into this MoU and take any action execute any documents required by the terms hereof; and that this MoU, entered into has been duly and validly executed and delivered, and is a legal, valid, and binding obligation of, enforceable in accordance with the terms hereof; and that the executants of this MoU are duly empowered and authorized to execute this MoU and to perform all its obligations in accordance with the terms herein.
- This agreement shall not be binding for any other agreement for either party. PARTIES shall be free and independent to carry on other services and trainings besides that covered under the scope of this agreement.
- The UPI & the INSTITUTION shall perform their duties in strict compliance with all applicable laws in India along with rules and regulations of duly constituted Government, authorities in India and shall obtain all licenses, restrictions or other approval, if any, required by laws in India in connection with the services to be rendered hereunder.
- The INSTITUTION shall strictly follow the UPI norms, rules and regulations for conducting the programs / for taking any service from the UPI.

Duration

This MOU shall be effective for a life time from the date of final signature. It may be modified or terminated by mutual written agreement by the PARTIES. This MOU may be terminated by either party upon three months advance written notice.

Declaration

The terms and provisions in this MOU also apply to any subsequent addendum to this agreement.
